# President's Message

As in the preceding financial year, 2021-22 has seen another period of considerable effort by the CMS board. With the vital development of the strategic plan behind it, the board shifted its focus to other challenges, including further refining CMS's brand and its place within the community.

The departure from QEII, with which CMS's identity was so intricately linked, has required an examination of how best to reflect a 96-year-old organisation that has evolved quite significantly into its current form.

While CMS remains committed to supporting the wellbeing of women, babies and their families, the ways in which it does this have changed. No longer will CMS provide direct services to families but rather aims to support other like-minded organisations and individuals to do so in various ways.



This shift in identity and operations from the QEII era has led the board to recognise the necessity of rebadging CMS to better reflect its current reality, while staying true to, and proud of, its long history.

The implications are far-reaching, affecting all the means through which CMS interacts with the community, from its website to its name, branding and social media.

It had long been evident to the board that the CMS website, which had been developed during the QEII years and still mirrored that period, was in need of an overhaul. More profoundly, it became clear that CMS needed a name and look that reflected a contemporary approach and aligned more closely with its change in direction.

The latter has proved a task requiring much discussion, debate, imagination and, not least of all, steadfastness and patience. It included a creative session at the National Gallery of Australia, using art as inspiration, ably facilitated by new board member Frances Wild, who was previously employed at the NGA.

At the time of writing, this work is proceeding well and, with the support of members, CMS hopes to rename itself in the coming financial year and begin to build a new brand on the strong

foundation of our notable history. In the meantime, we have moved forward on a related front and in March a new website went live. Thanks to CMS business manager Colleen Josifovski for creating a bright, stylish new online presence for CMS.

Important work has also been under way to secure solid foundations for CMS's financial future. The CMS board and finance committee have conducted a review of our investments and sought specialised advice on ethical investing as a not-for-profit organisation. This will see CMS move to a new investment structure in the 2022-23 financial year, and we look forward to reporting further on this.

Change has also been evident in the make-up of the board, with the retirement in November of two long-serving board members, Lynne Johnson and Philippa Lynch. Lynne served in many roles, including as president, public officer and chair of a number of committees. Over her 23-year involvement, she proved a passionate advocate and tireless worker for CMS. Under her guidance, CMS supporters the Knitters are still knitting and the Hydrangeas are still blooming. In Philippa's equally illustrious 23-year board membership, her legal background assisted the board on many occasions; particularly during the transition from QEII her wise counsel and steady, guiding hand were much appreciated.

In September, the board farewelled Robby McGarvey, whom we were sad to lose to a busy career in the community sector.

The board was delighted to award new Life Memberships to Lynne and Philippa, as well as to two other long-serving board members, Wendy Saclier and Viola Kalokerinos. All fully deserve this recognition, as per our constitution, for the "distinguished and valuable service" they have rendered to the CMS cause.

The subsequent vacancies on the board have been filled by three outstanding new members: Lisa Anderson, Tish Mercieca and Frances Wild. They bring invaluable skills to CMS and have already made significant contributions to board deliberations and oversight.



In terms of CMS projects, the continuation of our successful 2021 inaugural Mary Kirk Fellowship saw the publication of a peer-reviewed paper by Professor Hannah Dahlen *et al* in April 2022 in *Women and Birth*, the official journal of the Australian College of Midwives. Titled “A comparison of the *Woman-centred care: strategic directions for Australian maternity services (2019)* national strategy with other international maternity plans”, the paper is available to read on our website.

A second paper, analysing responses by an expert panel to the webinar, titled “Maternity service professionals’ perspectives of ‘the good, the bad, and the possible’ in Australian maternity services: a content analysis” is awaiting publication in the journal *Sexual and Reproductive Healthcare* at the time of writing.

In October, the board finalised the Mary Kirk Fellowship policy, and our thanks go to Philippa Lynch for her comprehensive and meticulous authorship of the policy. The fellowship will be awarded biennially to commission an academic paper and public lecture that will inform public debate and understanding of matters affecting women’s and children’s health and the wellbeing of families. The next fellowship will be awarded in 2023.

CMS has continued its close collaboration with Maternal Health Matters on the *Right Birth, Your Choice* project. CMS is funding the production of an online workshop to complement

the *Right Birth, Your Choice* video outlining birth choices for expecting mothers. We look forward to reporting on the completed project next year.



In March, CMS contributed \$5000 to the Rhodanthe Lipsett Indigenous Midwifery Charitable Fund. This will provide a Category A scholarship under the scheme. CMS is building its relationship with the fund, which bears the name of a beloved former CMS life member and legendary midwife, and hopes to become a long-term supporter of its scholarship scheme.

The board was delighted to learn that Vanessa Bakker completed her scholarship under the CMS scholarship scheme, achieving a Graduate Certificate in Health Care Management from Murdoch University. Congratulations, Vanessa.

In terms of document management, CMS has moved to a new system with Microsoft SharePoint, under the

Microsoft not-for-profit portal. Thanks to Colleen Josifovski for a great job of organising the transition and hours spent uploading files.

CMS also conducted a review of its insurance policies and has secured a better deal with a new broker, halving the previous premium.

As the Australian Charities and Not-for-profit Commission does not require an audit for charities of CMS’s size and revenue, by special resolution the constitution has been changed to reflect this. Sincere thanks to Kathryn Forster for her ongoing support and assistance in compiling the annual financial statement required by the ACNC.

Finally, heartfelt thanks go to the board – Maria Edwards (vice-president and treasurer), Fiona Smith du Toit (secretary), Kathy Metallinos (public officer), Jane Smyth OAM, Frances Wild, Tish Mercieca, and Lisa Anderson – for their contributions to a productive year, for their willingness to grapple with difficult decisions, their dedication and their good humour in the face of these demands. Thanks to Colleen Josifovski, as always, for her unfailing attendance to the business of running CMS, which she does with grace and diligence.

I commend this annual report to you and look forward to another productive year ahead for CMS.



**NOTES TO AND FORMING PART OF THE FINANCIAL STATEMENTS  
FOR THE YEAR ENDED 30 JUNE 2022**

- 1. Summary of Significant Accounting Policies**  
The Society was formed in 1927 and is incorporated under the Associations Incorporation Act, 1991, ACT. It is registered with the Australian Business Register - Australian Business Number 27 358 139 470. The Society is not registered for Goods & Services Tax purposes. The Society is registered as an income tax exempt charity and as a deductible gift recipient and is registered as a charity with the Australian Charities and Not-for-profits Commission.

This financial report is a special purpose financial report prepared in order to satisfy the financial reporting requirements of Division 60 of the *Australian Charities and Not-for-profits Commission Act 2012*. The Board has determined that the association is not a reporting entity.

The financial statements have been prepared in accordance with the notes to the financial statements and the following Australian Accounting Standards:

- AASB 101, *Presentation of Financial Statements*
- AASB 108, *Accounting Policies, Changes in Accounting Estimates and Errors*
- AASB 1048, *Interpretation of Standards*
- AASB 1054, *Australian Additional Disclosures*.

The financial report has been prepared on an accruals basis and is based on historic costs and does not take into account changing money values or, except where specifically stated, current valuations of non-current assets.

The following material accounting policies, which are consistent with the previous period unless otherwise stated, have been adopted in the preparation of this financial report.

- (a) Income Tax**  
The Association is registered as an income tax exempt charity with the Australian Tax Office. Consequently, no provision for taxation has been made in the financial statements.
- (b) Cash and Cash Equivalents**  
Cash and cash equivalents includes cash on hand, deposits held at call with financial institutions, other short term, highly liquid investments with original maturities of three months or less that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value, and bank overdrafts.
- (c) Trade and Other Creditors**  
These amounts represent liabilities for goods and services provided to the economic entity prior to the end of the financial year and which are unpaid. The amounts are unsecured and are usually paid within 30 days of recognition.
- (d) Investments**  
Investments are measured at fair value. Fair value is the market value of the investments as at the balance date.



### STATEMENT BY THE BOARD


